3. Not a single column should be left unfilled. Instead NIL/ Not Applicable should be mentioned.
4. If the space provided in application form is insufficient, increase the rows/column of the respective item. In all cases, the information sought be provided in the table provided.
5. Applicant shall submit the application in person or by post in the prescribed form together with all enclosures in envelope superscribed **"Application for the post of " " in the P.G. Department of " " so as to reach the Registrar (Establishment Section), Sardar Patel University, Vallabh Vidyanagar- 388120** on or **before 30/05/2017**, Application received after the due date will be liable to be disregarded. The University will not be responsible for postal delay, if any.
6. Applicants who are in service should apply through their present employers. Direct application will not be considered. However such a candidate can send in advance, one copy of dully filled in application form without any enclosure. so as to reach before the deadline. Such an application will be deemed in time, provided the application through proper channel is received within one week after last date. Persons employed after making application in response to this advertisement should bring **"NO OBJECTION"** certificate at the time of interview from their employers.
7. S.E.B.C. candidate should furnish the **Current financial year's "Non-Creamy-layer certificate"** of their parents in the prescribed Performa along with his/her application form, failing which the candidate will not be entitled to get the benefit of reserved category. - (ii) A minimum of ten years of teaching experience in university/college, and/or experience in research at the University/National level institutions/industries, including experience of guiding candidates for research at doctoral level.
- (iii) Contribution to educational innovation, design of new curricula and courses, and technology – mediated teaching learning process.
- (iv) A minimum score as stipulated in the Academic Performance Indicator (API) based Performance Based Appraisal System (PBAS), set out in the UGC Regulations of 2010, revised in Gazette of Govt. of India Dated 24/07/2013, 04/05/2016 & 11/07/2016 (Appendix-III)

**OR**

- B. An outstanding professional, with established reputation in the relevant field, who has made significant contributions to the knowledge in the concerned/ allied/ relevant discipline, to be substantiated by credentials.

**(B) Associate Professor**

- A (i) Good academic record with a Ph.D. Degree in the concerned/allied/relevant disciplines.
- (ii) A Master's Degree with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed).
- (iii) A minimum of eight years of experience of teaching and/or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry excluding the period of Ph.D. research with evidence of published work and a minimum of 5 publications as books and/or research/policy papers.
- (iv) Contribution to educational innovation, design of new curricula and courses, and technology – mediated teaching learning process with evidence of having guided doctoral candidates and research students.
- (v) A minimum score as stipulated in the Academic Performance Indicator (API) based Performance Based Appraisal System (PBAS), set out in the UGC Regulations of 2010, revised in Gazette of Govt. of India Dated 24/07/2013, 04/05/2016 & 11/07/2016 (Appendix-III)

**(C) Assistant Professor**

- A (i) Good academic record with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in a relevant subject from an Indian University, or an equivalent degree from an accredited foreign university.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.
- (iii) Notwithstanding anything contained in sub-clauses (i) and (ii) above candidates, who are, or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions.

**Further, the award of degrees to candidates registered for the M.Phil/Ph.D programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/ By laws/ Regulations of the Institution awarding the degrees and the Ph.D candidates shall be exempted from the requirement of the minimum eligibility condition of "NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities / Colleges / Institutions subject to the fulfillment of the following conditions: -**

  - (b) Evaluation of the Ph.D. thesis by at least two external examiners;
  - (c) Candidate had published two research papers out of which at least one in a refereed journal from out of his/her Ph.D. work;
  - (d) The candidate had presented two papers in seminars/conferences from out of his/her Ph.D. work;
  - (e) Open Ph.D. viva-voce of the candidate had been conducted.
- (a) to (e) as above are to be certified by the Vice-Chancellor/ Pro-Vice-Chancellor/ Dean (Academic Affairs)/Dean (University Instructions)”
- (iv) NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted.

- (i) Consistently good academic record with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) in Master's Degree in Business Management / Administration/in a relevant discipline or consistently good academic record with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) in two year full time PGDM declared equivalent by AIU/recognized by the AICTE/ UGC;

**OR**

First Class graduate and professionally qualified Chartered Accountant / Cost and works Accountant / Company Secretary of the concerned statutory body.

- (ii) Ph. D. or Fellow of Indian Institute of Management or of an Institute recognized by AICTE and declared equivalent by the AIU.
