- (A) The existing minimum qualifications for direct recruitment to the post of Registrar and equivalent post shall continue, namely, a Master's Degree with at least 55% of the marks or its equivalent grade of 'B' in the UGC 7 point scale. Experience required for the post of Registrar and equivalent shall be
- i. at least 15 years of experience as Assistant Professor in the AGP of Rs. 7000 and above or with 8 years of the service in AGP of Rs. 8000 and above including as Associate Professor along with experience in educational administration.
- OR**
- ii. Comparable experience in research establishment and/or other institutions of higher education.
- OR**
- iii. 15 years of administrative experience of which 8 years shall be as Deputy Registrar or an equivalent posts.
- (B) **Age Limit:** Not more than 57 years,

Candidates should send their application **neatly typed in prescribed form using Microsoft Word Arial Unicode fonts of size 11 in ONE COPY**, each with self-attested copies of certificate in support of their qualifications, experience, age, publication and all other claims made by them in a proper sequence of enclosures with numbering. **Handwritten application will not be acceptable.**
2. The word format for the application may be obtained from the Sardar Patel University Website www.spuvvn.edu/careers
3. Not a single column should be left unfilled. Instead NIL/ Not Applicable should be mentioned.
4. If the space provided in application form is insufficient, increase the rows/column of the respective item. In all cases, the information sought be provided in the table provided.
5. An Application Form should be sent along with **Demand Draft for Application fee of Rs.250/- for S.C/S.T. Candidates & Rs. 500/- for other Candidates (Non-refundable) in favour of "REGISTRAR, SARDAR PATEL UNIVERSITY, VALLABH VIDYANAGAR" in any Nationalized Bank payable at Vallabh Vidyanagar.** Write your Name, Address, and Mobile/Telephone Number on the back side of the Demand Draft.
6. Applicant shall submit the application in person or by post in the prescribed form together with all enclosures in envelope superscribed **"Application for the post of "Registrar" so as to reach the Registrar, (Establishment Section), Sardar Patel University, Vallabh Vidyanagar- 388120** on or **before 15/11/2019**, Application received after the due date will be liable to be disregarded. The University will not be responsible for postal delay, if any.
7. Applicants who are in service should apply through their present employers. Direct application will not be considered. However such a candidate can send in advance, one copy of dully filled in application form without any enclosure. so as to reach before the deadline. Such an application will be deemed in time, provided the application through proper channel is received within one week after last date. Persons employed after making application in response to this advertisement should bring **"NO OBJECTION"** certificate at the time of interview from their employers.

S.E.B.C. candidate should furnish the **Current financial year's** "Creamy-layer certificate" of their parents in the prescribed Performa along with his/her application form, failing which the candidate will not be entitled to get the benefit of reserved category. The reservation of posts shown above is for the candidate of Gujarat State origin only, therefore other candidates need not apply against these posts.
