Election to the Syndicate under Section 22 (1) (c) (d) & (e) of the Sardar Patel University Act.

Members of the Senate are hereby informed that the term of the present Syndicate will expire on 31-3-2018 and, therefore, election to the Syndicate will be held at the Annual Meeting of the Senate at 1.15 p.m. on 27/03/2018.

- 1) Two Heads of departments of the University,
- 2) Two Principals of the Degree Colleges affiliated to the University

AND

- 3) Ten Persons from amongst the fellows of the Senate.

Nomination forms will be available from **5/3/2018** onwards from University Syndicate Section **and can also be downloaded from the link: www.spuvvn.edu/downloads**

Nominations are invited separately for the following seats so as to reach the office of the Registrar not later than 03:00 p.m. on Wednesday, the 14th March, 2018, (as per statute -133).

- (i) Two seats to be filled by Heads of the Departments of the University from amongst themselves under section 22 (1) (c) of the Sardar Patel University Act.
- (ii) Two seats to be filled by the Principals of the Degree Colleges affiliated to the University from amongst themselves under Section 22 (1) (d) of the Sardar Patel University, Act.

AND

- (iii) Ten seats to be filled by election from amongst the fellows other than those who are Heads of University Departments or Principals of Colleges or are fellows under paragraph (D) under the heading "I-Ex-Officio Fellows", or under clauses (i) and (ii) of paragraph (B) under the heading "II-Ordinary Fellows" in Section-15 of the Sardar Patel University Act.

Nomination papers must contain names in full, designation, if any, and addresses of the two signatories who should be electors, and of the candidate nominated who must signify his consent on the nomination paper, as required under Statute-133.

The time and the date fixed for the scrutiny of the nomination papers is 10.00 a.m. on **Thursday, the 15th March 2018.**

Candidates or their duly authorized representatives will be entitled to remain present at the time of scrutiny.

A candidate nominated for election may withdraw his candidature by sending to the Registrar an intimation of withdrawal in writing signed by him within 24 hours from the hour fixed for the scrutiny of nomination papers.

In case there is a contest, the election will be held as stated above on **Tuesday, the 27th March, 2018**, the ballot box will be kept open till 3.00 p.m. on that day. Members coming after that hour will not receive the voting paper.
