#### **NOTIFICATION**

Sub:- ELECTION OF ORDINARY FELLOW ON THE SENATE FROM THE CONSTITUENCY OF REGISTERED GRADUATES.

As required under statute 131 of the university, it is hereby notified for the information of all concerned that Registered Graduates of Sardar Patel University, whose names were included in the Electoral Rolls of Registered Graduates as they stood on day <a href="https://doi.org/10.15">Thursday, 06<sup>th</sup> January 2022</a> subject to the corrections made or that may be made by the Vice-Chancellor under statute 116 are required to elect Four Representatives not being "teachers" or "secondary teachers" as Ordinary Fellows Under Section 15 II (A) (iii) of the Sardar Patel University Act. In the manner prescribed below (vide Statute 121):

Election of **four representatives** of the Registered Graduates to be elected faculty-wise to the Senate Under Section 15 II (A)(iii) of the act shall be in the following manner:

- (1) One representative by registered graduates in the Faculties of Arts and Education from among themselves;
- (2) One representative by registered graduates in the Faculty of Science from among themselves;
- (3) One representative by registered graduates in the Faculty of Business Studies and Management from among themselves;
- (4) One representative by registered graduates in the Faculties of Law, Home Science, Homoeopathy, Pharmaceutical science and Medicine from among themselves:

The Vice-Chancellor has fixed <u>Saturday</u>, the 5<sup>th</sup> February, 2022 as the date of Election. The places of elections will be notified hereafter.

## Schedules of Senate - 2022 Election is as Under

- 1. Last Date for receiving → 23<sup>th</sup> January, 2022 Sunday till 3.00 p.m. Nominations
- 2. Date of Scrutiny of → 23<sup>th</sup> January, 2022 Sunday at 4.00 p.m. Nominations
- 3. Date of withdrawal  $\rightarrow$  24<sup>th</sup> January, 2022 Monday till 5.30 p.m. of Nomination (Office hours)
- A list of the nominated → 27<sup>th</sup> January, 2022 Thursday candidates to be forwarded to electors
- 5. Date of Election  $\rightarrow$  5<sup>th</sup> February, 2022 Saturday 9.00 a.m. to 3.00 p.m.

Note: Nominations of candidates, in the form prescribed under Statute 133, (Which may be obtained from Room No.- 306, Syndicate Section, University Office) duly filled in and signed as required under the same Statute, should be forwarded to or delivered at the office of the University on <a href="23">23" January</a>, 2022, Sunday before 3.00 p. m.

- Every candidate shall before nominations have to deposit with the Registrar a sum of Rs. 50/- in cash. The candidate shall not be deemed to be nominated unless such a deposit has been made. The deposit shall be forfeited to the University or returned to the candidate, as the case may be; as per clauses (2) and (3) of Statute 135.
- As required under Statute 136, the Vice-Chancellor has fixed, the <u>23<sup>th</sup> January</u>, <u>2022</u>, <u>Sunday</u> as the date of scrutiny of nominations at the office of the University and has nominated the Registrar for the purpose. The candidate or his agent duly authorised by him in this behalf shall be entitled to be present at the time of scrutiny which will commence at 4.00 p. m. on, the <u>23<sup>th</sup> January</u>, <u>2022</u>, <u>Sunday</u> in the University Syndicate Hall, Ground floor.
- As per Statute 134(a) It shall be open to a candidate to withdraw from an election by sending in to the Registrar an intimation of withdrawal in writing signed by him/her within 24 hours from the hour fixed for scrutiny of nomination papers. (As per above schedules.)
- Copies of the Electoral Roll can be had from the University Office (Store Section) on payment of Rs.400/- in cash in the University Account Section.
