If yes, give a brief descripiton and a list of modules currently operational (maximum 500 words)	The Management Information System is a tool that integrates various functions and the stakeholders associated with an organization. Accordingly, in Sardar Patel University MIS is implemented efficiently for the benefit of various stakeholders including students, teaching and administrative staff, internal and external stakeholders and can be accessed as per the requirement. Students have to apply online for the admission. A student's entry to final exit can be completely tracked through a unique ID number provided to her/him at the time of registration. Invitation of application for admissions, prospectus for various programs, online admissions, syllabus, evaluation details, provisional mark sheet generation, degree awarding details, etc. are integrated through online developed system. Students related information like their academic performance, differently abled students, gender and caste, are generated by the system. Such information is useful in decision making processes like creating appropriate infrastructure to facilitate the students need belonging to various categories. Statistics generated by the MIS is used in monitoring the progress of the students during the program. The monitoring of the number of students in various programs and accordingly the decisions regarding the continuation of the

program at the institute level are done. Online process of scholarship from various government and other agencies is facilitated by the university, and the information thus generated is used to analyze the details of the beneficiaries. Examination registration forms are filled online having details like the available subjects and elective subjects chosen by each student. Departments and Colleges download the hall ticket of the students appearing in the exam, which in parallel provides statistics related to the students for the examination section. Information acquired through the examination form are used to plan and execute the entire examination process. Transparency in the examination process is assured using double barcode on the answer books to keep the identity of the student anonymous. The processing and preparation of results is fully automated and integrated with MIS. Information related to the number of students registered, appeared, passed, with various grades is drawn and it is used for further analysis of the results. Students can download provisional mark sheet from the portal. Application for seeking degree is done online. Lastly the exit formality is processed through MIS, which is used to trace the student progression. Details related to the staff members are fed into MIS like salary, leaves, and faculty welfare which are integrated and managed through information system. Information related to the service of various staff members is used to analyze the status of faculty availability in each program viz a viz student ratio, vacancies, etc. Data related to gender is used to analyze the gender audit among students and various categories of staff. Various financial and accounting details are integrated through efficient MIS. Procurement and purchases are routed through computer aided procedures. Various circulars and notifications for various stakeholders are updated on the website in time. The website of the university is so designed that any information required can be had easily.

Feedback Obtained

Feedback serves a crucial role in our consistent endeavor to maintain the excellence in higher education. The departments of Sardar Patel University regularly collect the feedback from the students at the end of each semester. The feedback has been collected with the help of a proforma seeking feedback for each subject and teacher respectively. It includes the parameters namely syllabus, its appropriateness, delivery, evaluation, transparency in evaluation, teaching skills and knowledge of teachers etc to name among few. Due care is being taken to keep the students' identity anonymous. The collected data has been analyzed with the help of descriptive statistics and the head of the department discusses the output of the feedback with each of the respective teacher individually and suggest the roadmap for improvement if required. The overall feedback with some healthy practices of the teachers, emerged during the feedback process is discussed in staff meeting. The particular feedback about administration has been shared with the non-teaching staff of the department with suitable direction. The teachers are also encouraged to provide their suggestions throughout the year, not only to the head of the department but also to the Hon. Vice-chancellor of the university. DRC and faculty meetings are the regular sources for obtaining and discussing constructive

suggestions about teaching and research initiatives among faculty members. Recruiters' feedback is also collected in a prescribed proforma and particularly considered at the time of revision of syllabus. By and large, the feedback of the parents helps the university to match the infrastructure facilities with the expectation of the society.

The university has set procedures for judicious distribution and utilization of the available financial resources for maintenance of physical, academic and support facilities like laboratory, library, sports complex, computer and classrooms. The University has well established estate section headed by University Engineer along with his team of engineers and other staff looks after various physical facilities. The university has 3 campuses namely university main campus, residential staff colony and satellite campus. The university has more than 30 educational buildings, 324 quarters, 8 hostels and 5 support services buildings. The estate section has been assigned the duty of quarters allotment to its permanent employee as well as students pursuing PhD. For the same estate section invites application through circular and after stipulated time the allotment is done on the basis of rules and regulation framed by syndicate vied item no. 35 dated 6/7/2017. For guest house allotment the university has prescribed form for the allotment and also has approved rates for educational and other than educational purpose. The university has its own University Science and Instrumentation Center (USIC) for maintaining the laboratory equipment. There are some sophisticated equipment which are maintained by the concern companies. In case of costly equipment above 5 lakhs, the university has a policy to procure them from suppliers/ manufacturers on a condition of providing 3 years warranty and 2 years AMC or 5 years warranty after expiry of 5 years warranty provided by suppliers at the time of Installation. Apart from this, the university permits to avail AMCs for sophisticated equipment from the manufacturer. Some of the equipment are maintained by the technical assistance of the departments. Computers and peripherals are maintained by USIC centre. The Director of Physical Education

takes care on the utilization of sports facilities. The university has a huge sports complex, which includes indoor games like badminton, table tennis, basketball. The University also has playground where students can play games like football, cricket, volleyball, basket-ball. The university has also constituted a sports committee including syndicate member to decide on the maintenance of the complex and various facilities. The University has central library called Bhaikaka Library along with various departmental library. The central library has librarian and library committee including syndicate numbers that looks after various policy decisions, procurement and maintenance of the books in library. The central library has been utilizing the SOUL 2.0 software procured by INFLIBNET for its function. The library has its own prescribed rules and regulation regarding membership, borrowing of books and fine. The technical assistants of library, computer center and INFLIBNET carry out troubleshooting and maintenance of SOUL software. The computer center carries out the installation and maintenance of the software in all the department and sections of the university. The computer center also maintains the networking and the internet facility in the entire university.

The Vice-Chancellor has been given power to approve the purchase order upto Rs. 2,00,000/- with due quotation process. The mandatory procedure for quotation is followed. The item costing above Rs. 2,00,000/- are purchased after inviting open tenders and taking the approval of equipment committee, FE and syndicate. [2] The academic and executive decisions are taken by committees where teachers and students representatives are members: Board of studies in each subject of discipline is composed of teachers and has statutory power to

consider the matters related to preparation of syllabus, course structure, mode of continuous evaluation, reviewing the examination papers, preparing the panel of examiners, etc. and approving them. Similarly, two Head of the Department, some faculty members are part of the various university authorities such as syndicate, senate, academic council, etc. Their inputs are considered before taking final decision.

Each college and affiliating institute is given full academic autonomy and partial examination autonomy. However, they have to adhere to academic calendar jointly approved by the Principals of the colleges/institutes and Head of the Department. The self-finance institutes are allowed to admit 20 of intake as management quota.

For sanitization of university departments cleaning staff was given training. 2. For Offline exam conduction guidelines were issued and continuous monitoring was done to minimize the risk of covid infection. To minimize the risk of covid transmission every staff and students were screened with pulse oxymeter and infrared thermometer. For that university staffs were given training to conduct the screening. 3. The university health centre in collaboration with IICISST has arranged free onsite Rapid Antigen Testing of teaching and support staff.

Roof Top Solar Panels connected to Grid (each of 20KW) were installed on the top of Humanities Building, Ladies Hostel, Electronics Department and MBA Department and that of 12KW in Mathematics and 32kW in Physics Departments. 35 to 50 load is met form them. 2. A unique natural air cooling system operating on a solar system exists in the UV Sports building. 6-inch diameter PVC pipelines are installed along the Short Wall and have been laid beneath 10 ft ground level and the outlet is set in the Basketball Court area which cools the Court Area. The hot air is lifted by the Turbo ventilators fitted at the Ceiling. 3. At a programme on Fit India Plogging Run to commemorate the 150th Birth Anniversary of Mahatma Gandhi, students took the pledge for the elimination of single-use plastic following the Prime Minister's campaign in making India plastic-free. 4. The Community Science Centre has established a CSC Nature and Environment Club under which various activities such as seminars, congress, visits to the botanical garden for school students, the orientation of school teachers, competitions, talks are organized 5. Rural Regeneration through Agro-Economic Research Centre (AERC) Research is a very crucial factor for an agrarian country like ours and rural regeneration is one of the objectives of various activities at Sardar Patel University. The university has been effectively contributing in both the areas through the Agro-Economic Research Centre (AERC), since 1961.AERC is one of the 15 AERC Centres/Units established by the Government of India (AERC having 15 sanctioned positions) mandated for the states of Gujarat and Rajasthan Cost of Cultivation Scheme for the state of Gujarat (CCS having 78 sanctioned positions), both are fully funded by the Government of India (total expenditure amount-AERC- Rs. 1.19 Crore, CCS- Rs 4.19 Crore). Every year, the centre conducts studies, awareness programmes, surveys. The major activities carried out by the centre are given below: Study reports completed by the Centre during the year under report on the topic of national importance are circulated by the Ministry of Agriculture and Farmers Welfare to the concerned departments of the Ministry for information, implementation and feedback purposes. Assessment of Livestock Feed and Fodder in Gujarat Assessment of Livestock Feed and Fodder in Rajasthan As entrusted by the Ministry of Agriculture and Farmers Welfare, GOI, AERC has undertaken the field work for the VILLAGE SURVEY WORK Village Survey Study in Rajasthan -Naurangdesar village, Hanumangadh District On the request of National Dairy Development Board (NDDB), Anand, AERC has completed the study on Breakeven Analysis in Dairy Farm Enterprises and Strategies for its Sustainable Growth under National Dairy Plan-I: Punjab, Karnataka, Bihar and Gujarat. On the request of Gujarat Economic Association Silver Jubilee Trust, Vadodara, a research study was undertaken at the Centre on Impact assessment of Goods and Service Tax (GST) on the use of selected inputs and adoption of Micro-Irrigation (MI) tools in selected districts of Gujarat On the request of Ministry of Rural Development, Government of India, University has conducted a Post-Project Evaluation Study of Sansad Adarsh Gram Yojana (Gujarat and Rajasthan) The data collected and submitted by the Cost Scheme for Gujarat (covering 16 major crops) is used by the Ministry of Agriculture and Farmers Welfare as well as Commission for Agricultural Cost and Prices, Government of

India for estimation and recommendation of Minimum Support Prices for 16 principal crops. Hon. Director of the Cost Scheme is the ex-officio member of the Government of Gujarat's Committee for Minimum Support Prices, which recommends the minimum support prices to the Government of India for its consideration for major crops grown in Gujarat for the welfare of the farmers.

The university is in the process of creating teachers' profiles in the university Management System to register and record their activities, progress, service related matters, association with various university bodies and authorities at one place. This would be in the line of student life cycle, already in operation. 7. A separate online module of affiliating system is being planned so that all the details of the institutes/colleges from the date of application, to scrutiny, to affiliation cycles till final approval, be made available online at one place in our University Management System.
