If yes, give a brief descripiton and a list of modules currently operational (maximum 500 words)	The Management Information System is a tool that integrates various functions and the stakeholders associated with an organization. Accordingly, in Sardar Patel University MIS is implemented efficiently for the benefit of various stakeholders including students, teaching and administrative staff, internal and external stakeholders and can be accessed as per the requirement. Students have to apply online for the admission. A students entry to final exit can be completely tracked through a unique ID number provided to her/him at the time of registration. Invitation of application for admissions, prospectus for various programs, online admissions, syllabus, evaluation details, provisional mark sheet generation, degree awarding details, etc. are integrated through online developed system. Students related information like their academic performance, differently abled students, gender and caste, are generated by the system. Such information is useful in decision making processes like creating appropriate infrastructure to

facilitate the students need belonging to various categories. Statistics generated by the MIS is used in monitoring the progress of the students during the program. The monitoring of the number of students in various programs and accordingly the decisions regarding the continuation of the program at the institute level are done. Online process of scholarship from various government and other agencies is facilitated by the university, and the information thus generated is used to analyze the details of the beneficiaries. Examination registration forms are filled online having details like the available subjects and elective subjects chosen by each student. Departments and Colleges download the hall ticket of the students appearing in the exam, which in parallel provides statistics related to the students for the examination section. Information acquired through the examination form are used to plan and execute the entire examination process. Transparency in the examination process is assured using double barcode on the answer books to keep the identity of the student anonymous. The processing and preparation of results is fully automated and integrated with MIS. Information related to the number of students registered, appeared, passed, with various grades is drawn and it is used for further analysis of the results. Students can download provisional mark sheet from the portal. Application for seeking degree is done online. Lastly the exit formality is processed through MIS, which is used to trace the student progression. Details related to the staff members are fed into MIS like salary, leaves, and faculty welfare which are integrated and managed through information system. Information related to the service of various staff members is used to analyze the status of faculty availability in each program viz a viz student ratio, vacancies, etc. Data related to gender is used to analyze the gender audit among students and various categories of staff. Various financial and accounting details are integrated through efficient MIS. Procurement and purchases are routed

through computer aided procedures. Various circulars and notifications for various stakeholders are updated on the website in time. The website of the university is so designed that any information required can be had easily.

1.4.2 – How the feedback obtained is being analyzed and utilized for overall development of the institution? (maximum 500 words)

Feedback Obtained

Feedback serves a crucial role in our consistent endeavour to maintain the excellence in higher education. The departments of Sardar Patel University regularly collect the feedback from the students at the end of each semester. The feedback form is prepared considering several essential parameters related to the syllabus being taught, the teaching-learning-evaluation methods. For example, the questions related to the syllabus pertain to its quality, effectiveness of its delivery, its relevance to the need of recent times. Printed copies of the feedback form are circulated among the students keeping their identity anonymous. The filled forms are collected and the responses to the questions are digitized for appropriate statistical analysis. Teachers' feedback on several aspects of teaching-learning-evaluation and administration, is also obtained and analysed simultaneously through online platform. The results of the analysis are studied carefully to identify the problems/issues which need to be rectified/addressed for further improvement in the studentcentric activities of the department. The issues are proactively addressed after critical discussion at the department level and, at the university level if necessary. The feedback from the alumni is collected by the departments as well as the university. Apart from the alumni association of the university, each department of the university has an active mechanism for interaction with the alumni and, alumni meets are organized frequently. Various issues related to the department and the university are discussed during the meeting and, their ideas, suggestions for the improvement in the performance of the university, in general, are taken into consideration. At the university level, the alumni feedback is mainly collected through on-line means. Feedback of the parents and the employers is also obtained through online platform. While these feedbacks are primarily aimed at knowing the extent to which the university is able to meet their expectations at various fronts, the employers' feedback is focussed on knowing their experiences with our students recruited by them, their satisfaction with the knowledge, skills and attitude acumen of the recruits. It helps the university to take new initiatives to evolve a selfsustaining ecosystem for creation and dissemination of knowledge.

In each post-graduate department, there is a mentoring system involving teachers of the departments. This helps in developing a cordial relation between teachers and the students. It has been experiencing by mentors that their involvement contributes towards the holistic development of the students and making their studies in the university pleasant and memorable. Career guidance is also given in this system. This one of the most effective systems functioning in the post-graduate department and it bridges the gap between students and the teaching community. This system is envisaged as one of the key factors in the performance of the students. The university teachers listen to the needs and expectations of the mentee and give suitable advice and fruitful guidance. Also, they clarify the goals and aspirations of the mentee. The mentors role is to guide, give advice, and support the mentee. The mentor focuses on the need of the students and regular updates about the student progress. It is a big challenge to encourage, exploring the new ideas and opportunities of the mentee. All mentors can always do more for the benefit of students. The mentor establishes consistent communication with the students and counsels them wherever necessary and closely monitors the growth of the students. They continuously monitor, counsel, guide, and motivate the students in all academic matters. A mentor plays a vital role in nurturing students and has a positive impact on students' persistence and academic achievement. A mentee can approach his/her mentor for both educational and personal guidance. It is conducted to help the students to strengthen their varied capabilities and to build an interpersonal relationship between the faculties and students. It is a reciprocity activity. It helps to mentor and mentee to reconnect to the people in our own organization and become reenergized. During the mentoring process student get knowledge about ins and outs of the university, his/their area, and his/her profession, also got deepened self-knowledge and self-understanding. Effective mentor ship has an overall positive effect on academic achievement, retention, and degree attainment, as well as on career success, career satisfaction, and career commitment. Mentor and mentee equal importance in the dyad and therefore the well-being of both is essential to a successful outcome. Self-awareness in terms of mentoring is very much important. These bridges the professions, organizations, public and private sector, injecting differing perspectives to enrich the process. The mentor has a chalked-out responsibility to take care of all the mentees to always support them as and when required. The mentor also works for finding out the hidden talents of the students in various aspects of academic, co-curricular, extracurricular, and extramural activities so that they can be promoted to do various activities in

The university has set procedures for judicious distribution and utilization of the available financial resources for maintenance of physical, academic and support facilities like laboratory, library, sports complex, computer and classrooms. The University has well established estate section headed by University Engineer along with his team of engineers and other staff looks after various physical facilities. The university has 3 campuses namely university main campus, residential staff colony and satellite campus. The

university has more than 30 educational buildings, 324 quarters, 8 hostels and 5 support services buildings. The estate section has been assigned the duty of quarters allotment to its permanent employee as well as students pursuing PhD. For the same estate section invites application through circular and after stipulated time the allotment is done on the basis of rules and regulation framed by syndicate vied item no. 35 dated 6/7/2017. For guest house allotment the university has prescribed form for the allotment and also has approved rates for educational and other than educational purpose. The university has its own University Science and Instrumentation Center (USIC) for maintaining the laboratory equipment. There are some sophisticated equipment which are maintained by the concern companies. In case of costly equipment above 5 lakhs, the university has a policy to procure them from suppliers/ manufacturers on a condition of providing 3 years warranty and 2 years AMC or 5 years warranty after expiry of 5 years warranty provided by suppliers at the time of Installation. Apart from this, the university permits to avail AMCs for sophisticated equipment from the manufacturer. Some of the equipment are maintained by the technical assistance of the departments. Computers and peripherals are maintained by USIC centre. The Director of Physical Education takes care on the utilization of sports facilities. The university has a huge sports complex, which includes indoor games like badminton, table tennis, basketball. The University also has playground where students can play games like football, cricket, volleyball, basket-ball. The university has also constituted a sports committee including syndicate member to decide on the maintenance of the complex and various facilities. The University has central library called Bhaikaka Library along with various departmental library. The central library has librarian and library committee including syndicate numbers that looks after various policy decisions, procurement and maintenance of the books in library. The central library has been utilizing the SOUL 2.0 software procured by INFLIBNET for its function. The library has its own prescribed rules and regulation regarding membership, borrowing of books and fine. The technical assistants of library, computer center and INFLIBNET carry out troubleshooting and maintenance of SOUL software. The computer center carries out the installation and maintenance of the software in all the department and sections of the university. The computer center also maintains the networking and the internet facility in the entire university.

Keeping this in mind, each Head of Department, all sections are given power to take decision on the purchase and ordering of chemicals, laboratory items, stationary items, other teaching material to the tune of Rs. 25,000/- to 50,000/- after inviting quotations. The Vice-Chancellor has been given power to approve the purchase order upto Rs. 2,00,000/- with due quotation process. The mandatory procedure for quotation is followed. The item costing above Rs. 2,00,000/- are purchased after inviting open tenders and taking the approval of equipment committee, FE and syndicate. [2] The academic and executive decisions are taken by committees where teachers and students representatives are members: Board of studies in each subject of discipline is composed of teachers and has statutory power to consider the matters related to preparation of syllabus, course structure, mode of continuous evaluation, reviewing the examination papers, preparing the panel of examiners, etc. and approving them. Similarly, two Head of the Department, some faculty members are part of the various university authorities such as syndicate, senate, academic council, etc. Their inputs are considered before taking final decision.

7.1.7 - Initiatives taken by the institution to make the campus eco-friendly (at least five)

1. As a step towards sustainability, a Water Recharging Cell has been installed in Womens Hostel No.3. 2. A Rain Water Harvesting structure - a tank with antifungal coating, with a capacity of 10,000 litres is installed since 2014 at University Community Science Centre. The potability test was carried out and the structure is demonstrated to all the visitors and community. 3. Development of a Green Belt in a newly established remote campus of Biosciences Department. What was a barren land in 2006 during the inception of the Department in the new campus, was converted to a lush green belt, rich in Biodiversity by the efforts of the Faculty and Students. In the last decade, the department has developed a forest-like green campus with extraordinary biodiversity: more than 200 trees consisting of more than 80 trees species a number of flowering nonflowering herbs and shrubs, more than 100 insect species including 75 recorded butterfly species, 65 spider species. The avian diversity as recorded on the dept. amounts to 75 species in the last five years. Specific programmes efforts in the conservation of birds, insects, snakes and plants have been carried out on regular basis. 4. Not merely Tree plantation but Tree Nurturing activities are also taken up on the campus. 5. A Eucalyptus Park has been created in one of the plots of the University. 6. Paperless processes are encouraged through ecommunication for academic and administrative activities - mainly declaration of Result, making the online announcement of the exam timetable, online availability of mark sheets and sending SMS to students for answer books observation are some of the activities. 7. The use of solar energy is done through the installation of solar panels. 8. The fashion of being eco-friendly is promoted by celebrating no-patrol day/bicycle day for youngsters. 9. Awareness and consciousness about values, traditions and heritage is raised by celebrating various days like World Sparrow Day, Ozon Day, Earth Day, Forest Trail. 10. The Departmental buildings are declared as Tobacco-free zone to reduce carbon emission to the environment and to generate health awareness.

Research Eco System and Performance The university has been striving since its inception to carry out the research work to generate new knowledge and disseminate it by teaching. Efforts are made to attract funds from various national agencies like UGC, DST, DBT, ICSSR and DAE etc. The Department of Chemistry along with the Department of Biosciences, Material Science, Physics and Computer Science have been awarded the Centre of Excellence in Applied Polymers for the period 2016 to 2021. A total of 12 Project Fellows and 2

technicians are working in this programme. A total of 11 of our departments have been recognised and received special funding under various programmes: UGC-CAS (Chemistry, Bioscience, Economics), UGC-SAP-DRS Programmes (Gujarati, Mathematics, Home-Science, Business Studies, Statistics and Business Administration). The Department of Physics is covered under the DST-FIST Programme. The Department of Biosciences is recognised for the DBT-IBT Programme. A total number of 37 sponsored research projects are in progress in our departments. , Similarly, 09 new projects sponsored by various national agencies are received during the year. The fund received for these ongoing and new projects amounts to 1534.93 lacs A total number of 250 research papers have been published in the journal of national and international repute during the year by 266 faculty members. 27 Research students have been provided financial assistance for research work under various schemes such JRF, Project Fellow etc. Similarly, the university awarded 137 PhD degrees and 50 MPhil Degrees during the year. 21 of our professors are awarded a fellowship by Gujarat Science Academy, Ahmedabad.

8. Future Plans of Actions for Next Academic Year

The university strives to provide all the possible opportunities to its learners and faculty members and makes all the possible efforts to help them enhance knowledge and skills through various means and practices. To implement the CBCS system in its true spirit and integrating technology in its various activities, the university is planning to initiate an innovative exercise in its evaluation practice which is Exam on Demand. This intends to save students from the burden of not-cleared papers at the time of regular exams and boost their morale. Efforts are on to arrange the online processes for admission, administration and examination system. In addition to this, the skill-based and employabilityenhancing short term courses are planned as add-on courses for the students already pursuing their bachelors or masters degree programmes. The University is also exploring the participation of industry or public sector undertaking units in formulating and submitting proposals for Bachelors in Vocational (B.Voc.) programmes in 'Advance Mobile Technology', 'Pharmaceutical Chemistry' and 'Dairy Products and Processing' etc. Research is one of the highly-rated skills, the need of the hour and a much-needed and expected contribution from the university teachers. The faculty members at the university are involved in various research activities at various levels. To promote research culture and to create worldclass research infrastructure for impactful research, proposals for creating a centre of Excellence in specialized areas of research under RUSA, State Govt. and UGC programmes will be formulated. To equip and help faculty members update themselves with the emerging trends, varied faculty development programmes (FDPs) would be conducted that would establish a multidisciplinary approach and inspire researchers for taking up quality research. MOUs are also being planned with the alumni of our University that are settled abroad for joint research work and exchange of faculty members. The university also feels that it is not enough to provide infrastructure, resources and/or funding but appreciation and recognition of the same are equally important. In this regard, the university plans to launch some sort of mechanism to reward the research endeavours of the faculty members as well as students. It is hoped that such an initiative will motivate everyone to do more and to do better too. The university plans to print the study material in English as well as in Gujarati language for the benefit of the students. The faculty members from the departments and the affiliated colleges will be involved to contribute collaboratively for the benefit of the students. As an effort to offer a platform for experiential learning, 'Earn While You Learn' Programme for the students on the campus is being thought of. In this programme, the interested students will be invited to carry out administrative support work. This would not

only provide an opportunity for the students to earn some money but also make them aware of the working of the university and learning the administrative skills.
