Within fields that are mutually acceptable, the following general forms of cooperation will be pursued:

- @ Collaborative research and publication
- @ Participation in seminar and academic meetings
- @ Exchange of academic material and other information
- @ Special short term academic program
- @ Joint organization of conference workshop symposium

The terms of cooperation for each specific activity implementation under this agreement of cooperation shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of the activity. And such agreement entered into as outlined above. Will form appendices to the agreement of co-operation. Each Institution shall designate a co-ordinator to develop and co-ordinate the specific activities agreed upon

The agreement becomes effective on the date of signature it is valid for five years with the understanding that either party may terminate the agreement with twelve (12) months' notice in writing unless an earlier termination is mutually agreed upon. Revision or modification may be proposed at any time effective from the date of written agreement signed by both parties

# Memorandum of Understanding

Between

Department of Sociology

Sardar Patel University, Vallabh Vidhyanagar, Gujarat

&

KAPADWANJ DON BOSCO SOCIETY managed  
DON BOSCO RURAL INTEGRAL SOCIAL TRAINING  
INSTITUTE (DRISTI), Kapadwanj

through this association will build confidence and prepare the students to have a smooth transition from academic to social life. The second party will provide its facilities for the hands-on training of the learners enrolled with the first party.

- 4) Guest Lectures: Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on various social issues and in house requirements.

#### CLAUSE 2: EFFECTIVE DATE AND DURATION OF MOU:

- 1) The MOU shall be effective from the date of its approval by competent authorities at both ends.
- 2) The duration of the MOU shall be for a period of 3 years from the effective date.
- 3) During its tenancy, the MOU may be extended or terminated by a prior notice of not less than six months by either party. However, termination of the MOU will not in any manner affect the interests of the students/faculty/scientists who have been admitted to pursue a programme under the MOU.

#### CLAUSE 3: CO-ORDINATION OF THE PROGRAMME INCLUDING FINANCIAL AGREEMENTS

The collaborative programme between SP University and DRISTI shall be coordinated by a coordination committee appointed by members of both the institutes.

There is no financial commitment on the part of the DRISTI, the First Party shall take up any programme mentioned in the MoU.

#### CLAUSE 4: CONFIDENTIALITY


During the tenure of the MoU both SP University and DRISTI will maintain strict confidentiality and prevent disclosure of all the information and data exchanged under the scope of this MoU for any purpose other than in accordance with this MoU.

Both the parties shall bind their respective personnel who come into possession or knowledge of any confidential information not to disclose the same to third parties without written approval of the disclosing party or use such confidential information for any use other than intended under this agreement of projects.

Further both parties shall put in place adequate and responsible measures to keep and store confidential information secure so as to prevent any unauthorized use.

#### CLAUSE 5: RESOLUTION OF DISPUTES

- 1) This agreement shall take effect and be construed in accordance with the Laws of India and be subject to the jurisdiction of the courts at ANAND.
- 2) The dispute or difference whatsoever arises between PARTIES in relation to or in connection with this AGREEMENT both the parties shall first try to resolve the dispute/difference amicably between themselves, failing which the matter shall be referred to and settled through arbitration. The arbitration proceedings shall be held in accordance with the provision of Indian Arbitration and Reconciliation ACT, 1996.
