SCOPE OF THE MoU

University and SynZeal.

1. SynZeal will develop a course curriculum keeping in mind various trends & requirements for the

Manufacturing/Quality area to enhance Good Laboratory/Synthetic Practices. Such curriculum

shall be discussed with officials of Sardar Patel University and also will plan for its completion

and implementation with the extension of support if required.

2. SynZeal will plan & ensure structured interactions with students of the Sardar Patel University

with the help of officials of Sardar Patel University to develop them as per need of SynZeal &

readily available for the requirement of SynZeal.

3. SynZeal may sponsor identified students of Sardar Patel University to undergo project at the

CONFIDENTIALITY

1. Any information on data, drawings, designs that come across by **Sardar Patel University** or its representatives during the interaction with **SynZeal** officials shall be maintained confidential.

2. The confidentiality and secrecy of information used shall be strictly maintained.

3. Whosever by virtue of this agreement, representing Sardar Patel University / SynZeal and carry out the research work/project in Sardar Patel University / SynZeal has to give a separate undertaking stating that they will abide by all the conditions of this MoU and shall maintain this confidentiality. (In any unforeseen eventually, the individual shall be responsible and not Sardar Patel University / SynZeal. The responsibility will be unilateral and not collateral.)

ADVISORY COMMITTEE

The **SynZeal** and **Sardar Patel University** will form a joint advisory committee consisting of two members each from **SynZeal** and **Sardar Patel University**. These members shall be nominated by the respective managements. The advisory committee shall meet at least three times a year to monitor the progress as well as the actual application of mutually agreed projects.

EFFECTIVE DATE AND DURATION OF MOU
