Syllabus with Effect from: June - 2010

The Five Years Integrated Law Course after 10+2 or its equivalent will be a double degree course comprising the Bachelor Degree in Management prosecuted simultaneously with the Degree Course in Law in an Integrated manner for a continuous period of not less than Five Years.

R. IL. 1. The Five Years Integrated Law course leading to a Degree of **B.B.A., LL.B.** shall be of Five years-Ten Semester full time course. The candidates pursuing this course shall be entitled to the Degree of B.B.A., LL.B. on successful completion Ten semesters.

R. IL. 2. Candidate who has successfully completed Senior Secondary School course ('+2') or equivalent (such as 11+1, 'A' level in Senior School Leaving certificate course) from a recognized University of India or outside or from a Senior Secondary Board or equivalent, constituted or recognized by the Union or by a State Government or from any equivalent institution from a foreign country recognized by the government of that country for the purpose of issue of qualifying certificate on successful completion of the course with minimum 45% of the total marks in case of General Category candidates and 40% of the total marks in case of SC and ST candidates in the aforesaid qualifying examination may apply for and be admitted into the Five Years Integrated Law Course of this University.

However, the maximum age for seeking admission is limited to 20 years in case of General category of applicant and to 22 years in case of applicants from SC, ST and OBC.

(Note: -Admissions to the reserved category shall be granted as per the prevailing rules of the Government of Gujarat from time to time.)

R. IL. 3. Admission to the First Semester of the Five Years Integrated Law Course may be on the basis of Minimum qualifying marks as per R. IL.2 above or Common Entrance Test and Personal Interview to be conducted by the college recognized for teaching Five Years Integrated Law Course of study by this University in accordance with the R. IL.2 above.

R. IL. 4. There shall be no lateral entry on the plea of graduation in any subject or exit by way of awarding a degree splitting the integrated double degree course at any intermediary stage of integrated double degree course.

R. IL. 5. Every year the total number of seats for First Semester of B.B.A., LL.B. Integrated Law Course shall not exceed 60 per one division or the maximum seats approved by the Bar Council of India from time to time.

R. IL. 6. There shall be a University examination at the end of each semester and all the semester Examinations shall be conducted twice in the year. Candidates having not less than 70% attendance in each paper shall alone be admitted to the examination. However, on reasonable grounds, the principal of the college recognized for teaching Five Years Integrated Law Course of study by this University may condone the required percentage of attendance in each paper.

R. IL. 7. No candidate shall be admitted to any Semester Examinations of B.B.A., LL.B. Integrated Law Course unless it is certified by the Principal of his college:



- (i) That he has undergone the course of instructions in the prescribed subjects to the satisfaction of the Principal at a college recognized for teaching Five Years Integrated Law Course of study by this University, and
- (ii) obtained at least 30% marks in the aggregate of all the subjects in the Internal Assessments conducted by the college.

R. IL. 8. Candidates desirous of appearing at Semester Examinations leading to B.B.A., LL. B. Degree, must forward their applications in the prescribed form to the Registrar through the Principal of the college on or before the date prescribed for the said purpose under the relevant ordinance/s.

R. IL. 9. The University will held Examination for all the papers prescribed for the B.B.A., LL.B. Integrated Law Course twice in a year i.e. in October/November and March/April.

R. IL. 10. For the purpose of deciding final University results of any of the Semester Examinations of B.B.A., LL.B. Integrated Law Course, the ratio between the Internal and External assessments shall be 50:50. The Internal Assessment shall be conducted by the college concerned on the basis of overall performance during the semester such as regularity of attendance, preparation and presentation of assignments, seminars, Quizzes, clinical projects, test paper scoring and class room participatory discussion.

R. IL. 11. There will be a Viva-voce examination of the candidates at the end of the Tenth Semester for the purpose of comprehensive assessment of his/her Practical Training papers which will be conducted by the Head of the Institution and the referee appointed by the University for the purpose.

R. IL. 12. No candidate will be allowed to reappear at the Examination/s which he has already passed.

R. IL. 13. The following will be the scheme of the Examination of the Five Years Integrated Law Course:

R. IL. 14 Standard of Passing:

To pass any Semester Examination for the Degree of B.B.A., LL. B. a candidate must obtain-

- (i) at least 40% marks in each paper at the University Examination as well as in the total of University Examination and Internal Assessment added together; and
- (ii) 50% of the total marks obtainable in the aggregate of all the papers.

R. IL. 15. Award of Classes:

- (1) The successful candidate who passes in all the papers at one sitting and obtain not less than 50% of the total marks obtainable will be placed in the **Second Class**.
- (2) The successful candidate who passes in all the papers at one sitting and obtains :
 - (a) at least 55% of the marks in the aggregate of all subjects separately in the Internal Assessments and the University Examination, and
 - (b) not less than 60% of the total marks in the aggregate of all the subjects will be placed in the **First Class**.
- (3) The successful candidate who passes in all the papers at one sitting and obtains :



- (a) at least 60% of the marks in the aggregate of all the subjects separately in the Internal Assessments and the University Examination, and
- (b) not less than 70% of the total marks in aggregate of all the subjects will be declared to have passed the Examination in **First Class with Distinction**.

(Note: Candidate passing any semester Examination in compartments will not be eligible for award of a Class.)

R. IL. 16. The candidate securing highest marks in External Assessment in aggregate of all the subjects of all the Semester Examinations taken together shall become eligible for awarding University Gold Medal/s. However, the candidate passing any Semester Examination/s in compartments will not be eligible for the University Gold Medal/s.

R. IL. 17. Exemption:

A candidate who has failed in any semester examination but has secured at least 50% marks in a paper/s may, at his option, be exempted from appearing again in that paper/s at the subsequent Semester Examination/s and will be declared to have passed the Semester Examination when he has passed in all the remaining paper/s in accordance with the provisions of regulation IL. 14

However, a candidate who has waived such exemption in any paper/s shall not be permitted to claim it on subsequent occasion/s.

R. IL. 18. A. T. K. T. :

A candidate, who has failed in any one paper in accordance with R.IL.14 or is not exempted in any one out of all the papers according to R.L.17 in each Semester Examination for the degree of B.B.A., LL.B. of this University, will be allowed to keep Semester/terms. However, the candidate shall not be eligible to appear at the Tenth Semester Examination unless he/she has passed in accordance with Regulation IL.14 in all the papers upto Ninth Semester.

Provided, further, that such a candidate shall not be eligible for a Class, Prize or Scholarship.
