<u>THE CONSTITUTION OF INDIA</u> <u>CHAPTER-IV A – FUNDAMENTAL DUTIES</u>

ARTICLE 51 A

Fundamental Duties – it shall be the duty of every citizen of India:

- (a) To abide by the constitution and respect its ideals and institutions, the National flag, and the National Anthem.
- (b)To cherish and follow the noble ideals which inspired our national struggle for freedom.
- (c) To uphold and protect the sovereignty, unity, and integrity of India.
- (d)To defend the country and render national service when called upon to do so.
- (e) To promote harmony and the spirit of common brotherhood amongst all the people of India transcending religious, linguistic, and regional or sectional diversities; to renounce practices derogatory of the dignity of women.
- (f) To value and preserve the rich heritage of our composite culture.
- (g) To protect and improve the natural environment including forests, lakes, river, wildlife and to have compassion for living creatures.
- (h)To develop the scientific temper, humanism and the spirit of inquiry and reform.
- (i) To safeguard public property and to adjure violence.
- (j) To strive towards excellence in all spheres of individual and collective activity so that the nation constantly rises to higher levels of endeavours and achievement.

Preamble (M.Ed.) Two years and four semester course)

The Master of Education (M.Ed.) Programme is a four-semester professional programme in the field of Teacher education which aims at preparing teacher educators and other education professionals including curriculum developer's educational policy analysts, planner, administrators, supervisors, school principals and researchers. The completion of the programme shall lead of M.Ed. degree with specialization either in elementary education (up to class VIII) or in secondary education) classes VI-XII)

Aims of the programme

2 years M.Ed. programme is designed to provide opportunities for students to extend as well as deepen their knowledge and understanding of Education, specialize in selected areas, and develop research capacities, leading to specialization in either elementary educational or secondary education.

To develop in prospective teacher educators' skills relates to independent study of literature, research, academic writing, professional communication, and teamwork. It should also endeavors to develop in the future practitioners a deep and critical awareness of professional ethics and ability engage in and reflect on practice.

Duration

The M.Ed. programme shall be of duration of four semesters including field attachment for a minimum of 4 weeks and research dissertation. Students shall be permitted to complete the programme requirements of the two-year programme within a maximum period of three years from the date of admission to the programme. The semester break should be used for field attachment/practicum/other activities.

Working Days

There shall be at least 120 working days each semester exclusive of the period of admission and inclusive of classroom transaction, practicum, and field study and conduct examination. The institutions shall work for a minimum of thirty hours in a week (five of six days) during which faculty and students concerns with the conduct of the programme shall be available for interaction, dialogue, consultation, and mentoring students.

The minimum attendance of students shall be 80% for theory courses and Practicum and 90% for Field Attachment

Eligibility

- (a) Candidates seeking admission to the M.Ed. Programme should have obtained at least 50% marks of an equivalent grade in the following Programmes:
 - (1) B.Ed.
 - (2) B.A., B.Ed., B.Sc., B.Ed.
 - (3) B.EL.Ed.
 - (4) D.EL.Ed. with an undergraduate degree (with 50% marks in each)

Reservation and relaxation for SC/ST/OBC/PH and other applicable categories shall be as per the rules of the Central Government / State Government whichever is applicable along with university rules in force time to time.

M.Ed. Programme has 80 credits in total: 44 for core courses, 20 credits for specializations, 8 credits for field internship (4 Credits in a teacher education institution and 4 in the area of specialization), and 8 credits for research leading to dissertation.

The taught courses will also have practicum component. Each credit in a taught course is equated to one hour of teaching or two hours of seminars / group work / Laboratory work / Field work / workshop per week for 16 weeks. Thus, a 4-credit course entails 4 hours of regular teaching per week or as much as 8 hours of teaching and other programme activities. While conceptualizing the credits the Choice Based Credit System (CBCS) proposed by UGC should be adopted.

Since the M.Ed. programme structure proposed in this report is hinged on school and teacher education institutions (and other sited) based activities, the M.Ed. calendar should be developed keeping in mind the schedule of these institutions.

Degree of Master of Education (Regular) to be implemented from June – 2021.

R.PG.ED 1.

A candidate who has taken the degree of Bachelor of Education or B.Ed. (English) of this University or an examination recognized as equivalent there to by the University and the NCTE will be eligible for admission to the FOUR SEMESTERS of this university subject to the rules regarding the minimum percentage of marks and admission rules etc. prescribe the university for the admission of master's degree from time to time. The new admission rules as prescribe by the NCTE will be in force please seeing the page no.3 for NCTE prescription.

R.PG.ED 2.

The semester examination for the degree of Master of Education included core courses, foundation courses, specialization courses, optional courses, dissertation, and internship applicable to each of the students in terms of their specialization and requirements.

All the core courses will be of hundred (100) marks divided in to 70 University exam and 30 Internal exam including seminar and one practical work in each of the subjects. (All the Semesters)

The specialization course will be of 100 marks and divided into 70 University exams and 30 internal examinations (Semester-3)

R.PG.ED 3.

All the candidates have to select any one specialization course in the third semester that is elementary education two papers or secondary education two papers each having 100 marks including internship under each of the specialization. Besides other courses in third semester.

R.PG.ED 4.

In the fourth semester all the students will be in specialization course for each of the group there are three courses on specialization, and it will be optional for the student to opt for any one group as specialization.

R.PG.ED 5.

All the students have to go progressively for the dissertation work and each of the students will have to submit the dissertation in the fourth semester and in a stipulated time during the second semester there will be progressive evaluation of the dissertation reaching to the four semesters.

Dissertation work will be continuing in three semesters starting from second semester and marks for second semester will be 50 for third semester will be 50 for fourth semester will be 200 Each student have to report about the progress of dissertation through his or her concerned guide to the HOD. The assessment of the dissertation work to progress will be done before the second and subsequent each semester. At the end of fourth semester dissertation will be evaluated out of 150 marks and viva-voce will be of out of 50 marks.

R.PG.ED 6.

Over and above all the students will have to submit seminar and practicum in each of the subjects.

R.PG.ED 7.

The attendance is normally of 80 % of the working days. The relaxation in the matter will be given by the University or the Departmental committee in typical type of circumstances.

R.PG.ED 8.

All the students have to submit internship report to the concerned mentor of the department.

R.PG.ED 9.

Admission to various (optional) course / courses will be decided by the Head of the Department of Education on the basis of resources available.

R.PG.ED 10

A candidate who has passed the qualifying examination from other university will not be admitted without producing the eligibility certificate from Sardar Patel University.

R.PG.ED 11

Candidates desirous of appearing at the semester examination must forward their applications in the prescribed form to the Registrar, through the Head of the Department of Education on or before the date prescribed for the purpose under the relevant ordinance.

R.PG.ED 12

No candidate will be admitted to any examination in the concerned subject unless certified by the Head of Department.

(i) That he/she has attended the course of study prescribed for the respective semester to the Head's satisfaction.

(ii) That he/she has obtained at lea

R.PG.ED 13

Every candidate will be required to select the problem of dissertation in the beginning of first semester and which will be required to be approved by the Head of the Department within 10 weeks of admission. The candidate will thereafter begin work in his/her Dissertation and will submit a progress report every fortnight to the guide regarding the dissertation work. If the guide of the candidate is not satisfied regarding the progress of the dissertation work, he/she will recommend through the Head of the Department to cancel the registration of such a candidate.

R.PG.ED 14

Candidates studying for the M.Ed. degree examination will be required to submit two copies of dissertation and synopsis before the date fixed by the Head of the department. The Logbook and the progress record will be judged by the panel of internal guide in the department and will assign marks for the purpose of internal assessment. In each semester Dissertation assessment interviews will be conducted in the department.

R.PG.ED 15

In viva-voce, candidates will be examined on the dissertation.

R.PG.ED 16

The foundation course will be of 50 marks and it will be only internal.

R.PG.ED 17

The marks for the internship will be given by the concerned mentor of the faculty with the consultation of HOD.

R.PG.ED 18

The Head of the Department of Education will in join consultation other teachers of the department prepare in the beginning for the semester a scheme for the internal assessment and communicate to the students and the University to a record of the internal assessment will be maintain in the department office and the teacher concern for the affiliated at their respective colleges or institutions.

R.PG.ED 19.

Standard of passing: To pass the M.Ed. Semester Examination candidate must...

- (a) obtain at least 40% of marks in each course in the internal assessment as well as at the external examination.
- (b) obtain at least 40% of marks in dissertation in the internal assessment as well as at the external examination.

R.PG.ED 20

Award of Class

(i) Successful candidates will be placed in the Second Class if they obtain.

- (a) at least 50% of marks separately in the internal Assessment and the University Examination, and
- (b) 50% or more but less than 60% marks of the total marks.
- (ii) Those of the successful candidates will be placed in the First Class if they obtain.
 - (a) At least 60% of marks separately in the internal Assessment and the University Examination, and
 - (b) 60% or more but less than 70% marks of the total marks.
- (iii) Successful candidates will be placed in the First Class with Distinction if they obtain.
 - (a) At least 70% of marks separately in the internal Assessment and the University Examination, and
 - (b) 70% or more of the total marks.

Grade system, conversion of marks into grade and grade into the marks will be decided by the university as the common evaluation procedure.

R.PG.ED 21

As M.Ed. is a Four Semester course

- (I) A candidate failed in the first semester will be permitted to pursue course for M.Ed. second semester examination.
- (II)A candidate failed in first and second semester will be permitted to pursue for M.Ed. third semester examination but during the third semester the candidate should clear all the previous semester courses otherwise is result of third semester will not be declared by the University.
- (III) Only the candidates who have cleared all the three semesters will be permitted for the M.Ed. fourth semester however the candidate who has not cleared the course of only of the third semester will be permitted for the fourth semester M.Ed. course but after clearing all the previous courses his or her result will be declared by the University.
- (IV) For total numbers of trial university general rules will be applicable along with attendance in each of the semesters.
- (V) Students should complete and submit their work meaningfully using their formal scheduled time of the department and by additional time devoted for the same. It is the student's responsibility to submit all the work as per instructions.
- (VI) The affiliated or recognized institution running M.Ed. course will produce a list of Dissertation problem in due course for the approval of the Head, Department of Education, Sardar Patel University, Vallabh Vidyanagar. The Departmental head shall make suggestions to change the Dissertation problem or cancel the same, if so necessary, with the consultation of the head of the institution concerned. Even after the approval of the Dissertation problem, if any change is required to be done in the

Dissertation problem title, the approval of HOD, Dept. of Education, Sardar Patel University Vallabh Vidyanagar will be required. This is to be done during the first semester.
