1.0		ADMISSION:					
	1.1	Admission Committee of the Institute shall decide / organise the admissions to Master in Interio Design (MID).					
	1.2	Minimum qualification/requirement for admission to Master in Interior Design (MID):					
		B.Arch./Diploma in Architecture (at par with Degree) approved by the Council of Architecture or its equivalent from a recognised University with minimum 50 % aggregate marks.  OR					
		Three years Bachelor in Interior Design or its equivalent from a recognised university with minimum 50 % aggregate marks and an Office Training of 6 months.  OR					
		B.E./B.TECH.(Civil, Mechanical, Electrical) approved by recognized university with minimum 50% aggregate marks					
		Admission to MID shall be based on Group Discussion & personal Interview conducted by Institute.					
	1.3	All candidates selected for admission shall pay fees as laid down by the Institute from time to time & register for their studies by the 1st day of the Semester or the day designated & announced in advance, failing which their admission shall be cancelled.					
	1.4	No student shall be admitted to the School unless he/she has signed the declaration in the prescribed format before joining.					
2.0		DISCIPLINE :					
	2.1	High Standard of Discipline is expected from all the students enrolled. Basic Guidelines of the Code of Conduct has been inducted in the agreements signed by the students & Parent/Guardian, at the time of admission/ Registration.					
	2.2	Any non observance of the laid down norms will result in Disciplinary/Administrative action including expulsion from the programme. Action will be considered on gravity & line of action initiated as recommended by the Academic Committee of the School.					
3.0		REGISTRATION:					
	3.1	All students must register for M I D Course in Semester I to cover 25 Credit. For all subsequent semesters, students must register for all courses offered in the Semester for which the student is eligible (Refer Teaching Scheme).					
	3.2	One must have paid full fees for the Semester to be a bonafide student, and he/she must be registered for all subjects for which the student is eligible. Only bonafide students will be entitled to facilities on & off campus, concessions, introductions etc.					
	3.3	A student is not permitted to continue after a break of more than 2 semester consecutively for purposes of work experience, travel or alternative studies, or for any other valid reason. A continuous break in studies beyond 02 semesters will mean that the student status is forfeited and the student is required to apply for readmission.					
	3.4	A student may be denied Registration if he/she has been debarred or suspended from studies due to disciplinary action taken by the School/ or any other recognised Institute.					
4.0		STAGE CLEARANCE :					
	4.1	A student at any time, can carry a maximum of 12 credit backlog only except at Stage Clearance (see below). Students having more than 12 credits backlog shall not be permitted to register for any subsequent Semester till they have reduced the total backlog to less than 12 credits.					
	4.2	FIRST STAGE CLEARANCE :					
		For students to qualify for Registration to Second Year Master in Interior Design Course, a student must have cleared 46 out of the 50 credits of First Two Semesters.					
	4.3	SECOND STAGE CLEARANCE :					
		In order to qualify for Registration to the Thesis Semester, in Master in Interior Design Course, the student should have cleared 72 out of the 75 credits.					
	4.4	Students in order to be eligible for the award of the Masters Degree should have cleared fully, all the credits (Core + Elective) and should have completed all the Related Study / Summer / Winter Programmes.					

4.0	4.5	University or recognize University or College h	ted at Higher Levels, through higher - level admissions, coming from other inized colleges, shall be exempted from courses cleared successfully at the level is coming from up to the level at which the student is admitted subject to University and course by course grant of exemption as decided by the littee.
