NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MoU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1 CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish co-operation.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities, collaboration for academic add-ons and development of projects.
- 1.3 The parties shall co-operate with each other and shall as promptly as is responsibly practical, relevant agreement.

CLAUSE 2 - SCOPE OF THE MOU

- 2.1 Institutional Training & Visits : Mutual Institutional interaction will provide an insight into the latest developments / requirements of both Institutes to permit the Faculty and Students to visit respective Institute and also involve in Institute Training Programs as per rules and regulations of both institutes. This will provide confidence & smooth transition for students work.
- 2.2 Guest Lectures: First and second party to extend the necessary support to deliver guest lecturers to the students.
- 2.3 Placement of trained students: First and second party will actively engage to help the delivery of the training and placement of the students on the technology trends and in house requirements.
- 2.4 Collaboration for academic activity, Research and development of add-on projects.
- 2.4 There is no financial commitment on the part of both the party to take up any program mention in MoU. If there is any financial consideration, it will be dealt separately.
- 2.5 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required.

CLAUSE 3 - VALIDITY

3.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms.

CLAUSE 4 - RELATIONSHIP BETWEEN THE PARTIES

4.1 It is expressly agreed that First Party and Second Party are acting under this MoU as independent contractors, and the relationship established under this MoU shall not be construed as a partnership.
