The Indian Railways aims to generate around Rs. 30,000 crore additional revenue over the next five years and subsequently nearly Rs. 30,000 crore per year through the new long term land lease policy, which will accelerate setting up of 300 cargo terminals. The additional revenue generation will be on account of increased freight movement by railways, officials said.

Speaking to reporters, Railway minister Ashwini Vaishnaw said the target of developing 300 Gati Shakti terminals within the next five years is very much possible, considering that nearly 150 players have submitted proposals and have shown interest for setting up of terminals. He said that this will boost the cargo movement on railway network and help bring down overall logistics cost.

The Union cabinet on Wednesday had approved a policy on long- term for easing of Railways land for 35 years for setting up cargo related projects and this can be extended for another 35 years.

The erstwhile Indian factory of Harley-Davidson, shut since the American bike maker quit solo operations in the country to join hands with local Hero Moto, is set to give a fresh lease of life to LML, the two wheeler brand of yesteryears. In the 1990s, it had challenged Bajaj and other automakers with its chic and urban scooter designs before shutting down just a few years ago due to poor sales and losses.

Originally Lohia Machines Ltd. (LML) had partnered Italy's Piaggio in the 80s to sell the LML, Vespa scooter in India. However, with its partnership with Piaggio breaking down around 1999, and failure of several revival plans- including the launch of motorcycles through a partnership with Daelim Motor of South Koria- the company went into insolvency and had to shut shop around 2018. Now it is coming back in a new avatar after the brand was purchased by SG Corporation Mobility, a company that dabbled in consumer electronics and most recently in electric two—wheelers.
