- A. The appellant had a sugar factory adjacent to the respondents own land cultivated by a water channel, which ran in between the premises of the sugar factory and the land. The appellant stored a large quantity of molasses, a bye product in the manufacture of sugar, in the three tanks of the premises of the factory. One of the tanks close to the respondents land was separated only by the said water channel. Due to borrowing activity of the rodents the said tank contain molasses collapsed and molasses respondent's land damaging the standing paddy and sugar cane crops. Is appellant liable for this damage. Justify the same with proper case laws.
- B. A chemical co., the effluents treatment plant of the industry was not in operation. Partially treated effluents were discharged joining in tank thereby causing water pollution in the tank resulting in danger to public life. The concerned authorities directed closure of industry. Does the concerned authorizes decisions correct to close the industry. Explain the same with proper case laws.
- C. The petitioner contended that the forest cover in the state of Madhya Pradesh has been gradually shrinking. The court gave directions to take urgent steps to prevent any destruction and damage to the environment the floura and fauna and wildlife in those areas. The Supreme Court directed the state Government to take steps. What was that steps and is it appropriate. Explain the same with case law.
- D. The Petitioner filed a writ petition under Art.32 of constitution of India requesting the Supreme Court to issue orders to prevent air pollution on the Taj Mahal a cultural heritage. The Supreme Court gave orders to all the industries that they should use gas instead of coal and those which do not use gas should close their units. All emporia and shops functionally within the Taj Premises have been directed to be closed. Agra bypass road shall be constructed to divert the traffic which passes through the city. Industries should be shifted and they should be given incentives. Do you agree with this orders. Justify the same with proper case laws.
