Answer as Instructed

- 1. Answer any TWO Questions from the following. [2 x 5 = 10 marks]
- [a] 'Z' is a foreign power ruling the country M. In 1947 it is decided to give Independence. Before implementing Independence Z divides the territory into two separate States 'X' and 'Y'. The Ruler of the border Princely State 'K' decides to join 'X'. Un-official armed forces of 'Y' try to occupy the Princely State 'K'. 'X' sends its huge military forces into 'K' and 'Y's forces are compelled to retreat and while doing so they try to capture certain part of the Princely State. Advise 'X' for a legal action.
- [b] 'X' is a large country while 'Y' is a small Emirate on its border. 'X' sends its armed forces and tries to amalgamate 'Y' into its territories. 'Y' appeals to the United Nations Organizations [UNO] and it decides to send a Peace Keeping Force in order to protect the 'Y's sovereignty by expelling the 'X's Forces. It is done. But 10 Soldiers of the Peace Keeping Force are killed and thrice than that are injured. Advise the sufferer.
- [c] 'S' incorporates a private limited company called 'S & Co. Pvt. Ltd.' Most of the ,that is nearly 70% of the share of the Company were purchased by 'S' and his son 'Y'. 'Z', not related to 'S' purchases 20% of the shares. Rest of them was purchased by the other people. 'S' having, full charge of the Management of the Company started to raise the capital of the company by taking loans by way of debentures. Finally the Company is liquidated on account of the heavy losses in business. 'Z' sues 'X' & 'Y' for fraud and criminal conspiracy. You are an Amicus Curie. Advise the Court.
- [d] 'X' is an International Union very akin to a Super-national Community. 'Y' is an old Member of the Union. Membership is still increasing. Meanwhile the people of 'Y' took a Referendum in favour of Exit from the said Union. 'Z' is another Member having 'Free Trade' Relations with 'Y'. The Exit may impose heavy taxation upon the goods of 'Z' while entering 'Y's territories. Advise 'Z'.
