Gold prices touched a record high on Tuesday, in line with a surge in global prices that recently took the yellow metal to a 15 year high at New York. In the commercial capital, standard gold opened at its highest level of Rs. 9,230 per 10 grams and closed at Rs. 9,280 on Tuesday, up from the previous day's close of Rs. 9,170. Silver also closed on an all time high of Rs.20,120 per kg. up by Rs. 275 per kg.

The climbing price has given traders sleepless nights. An official of the Bombay Bullion Association said that a weak dollar has pushed up the price in the international market. Soaring prices for gold have hurt retail sales and imports. A dealer at Zaveri Bazaar said, "Gold demand in the city is hardly 100kg a day, as against the earlier 600 plus kg. that we were used to dealing with. Moreover, prices are bound to rise further in the coming days."

Domestic prices follow world trends as India imports 1.6 tonnes a day to meet about 70 per cent of its demand.
