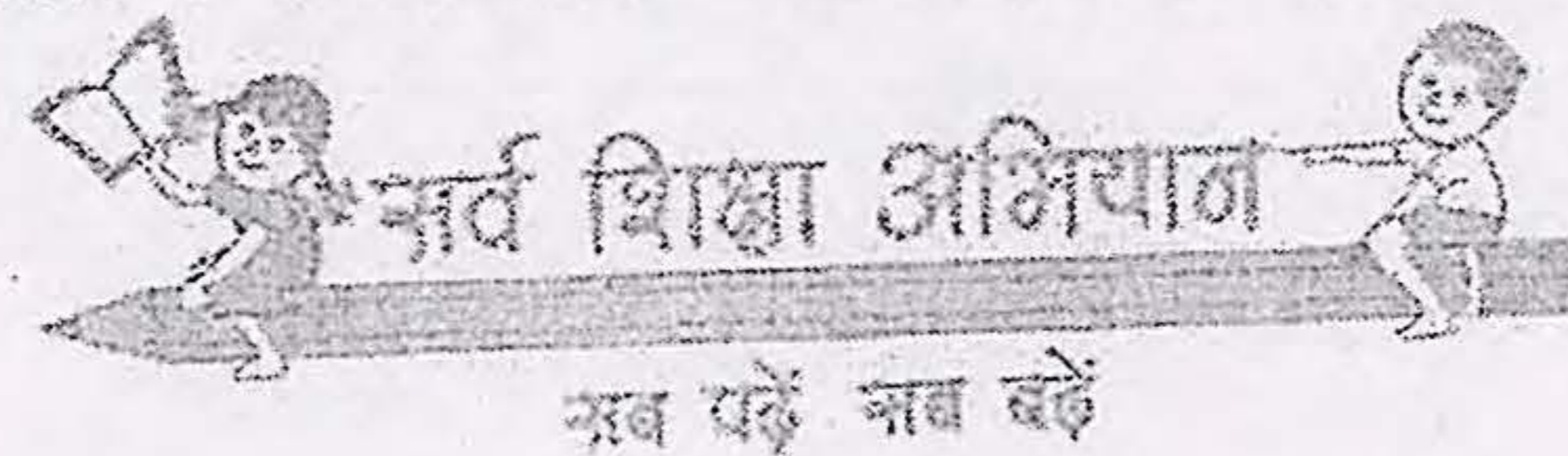
Kindly refer to my letter No. 16-3/2009-DL, dated 21st August, 2009 [copy enclosed] regarding Optical Fibre Cable (OFC) based 1 Gbps connectivity to National Knowledge Network (NKN) Point of Presence (PoP) to all the bonafide Universities in the country under the National Mission on Education through ICT (NME-ICT) on a 75 : 25 cost sharing basis between the Central Govt. and the Universities concerned, which includes university level institutions. You would be glad to know that BSNL – MTNL combine has started the work in this regard. This is in addition to the already ongoing work of progressively providing 10 Mbps Broadband over Virtual Private Network (BBoVPN) to all the bonafide Colleges of the country through upto 20 individual connections over copper wire with ADSL modems on 75 : 25 cost sharing basis between the Central Govt and the respective Colleges. You are also aware that 25 % contribution of the University and the College has to be paid by them to the BSNL directly. As indicated earlier, the approximate one time upfront payment for each University works out to Rs. 50 lac plus service tax for the connectivity for a 10 year period and Rs. 10 lac plus service tax for setting up a Local Area Network (LAN) of 400 nodes, if required by the University. In case of Colleges, approximate quarterly payment works out to Rs. 6500/- only. BSNL, on its part has agreed to provide 10% rebate on cost of connectivity.

2. As the connectivity is the key to delivery of e-contents and collaboration between institutions / academicians / experts / researchers, in order to fast track the roll out of connectivity to Universities and Colleges, I would request you kindly to expeditiously take the following steps:

(a) obtain required approvals for meeting the upfront payments to BSNL for the 1 Gbps link to NKN and for the LAN and to made adequate budget provision for the same,

(b) nominate a nodal officer whom BSNL / MTNL could contact for these works, and who, in turn, could co-ordinate these activities in the University on your behalf,

(c) identify a 10' x 10' room where the 1 Gbps connectivity could be provided and routers / switches for NKN connectivity and LAN could be placed,




(d) grant permission for laying of cables etc.,

(e) permit Principals of constituent and affiliated colleges of your University to avail of the BBoVPN connectivity at the costs indicated above, and also to consider providing space for erecting mobile tower of BSNL free of cost so as to get optical fibre in the college campus.

3. I shall be grateful for your co-operation in digitally connecting India's educational institutions to make them e-learning enabled in the shortest possible time. In case you need clarifications or assistance, kindly feel free to e-mail to me at the address given above.

Introduction:

The proposal of assigning and allocating the grant for Rs. 4,80,00,000/- was under consideration as per the above mentioned point No. 1, for providing the facility of GBPS Connectivity under the Scheme of NMEICT to the State Universities of Gujarat, Gandhinagar.

Resolution:

After mature and sound thinking, the students and teachers of the below mentioned 08 universities of the State Government are to be provided with qualitative teaching and learning material through National Knowledge Network under the Scheme of NMEICT. Each of the 08 universities will be provided with the Connectivity of 1 GBPS Speed. The total approximate expenditure for the period of 10 years for each university is likely to be 2 crore rupees. Out of this expenditure, 75% is to be paid by the MHRD. Each university has to bear the expense of Rs. 50 lacs in advance for the period of 10 years. There is also a provision of providing LAN Connectivity of 400 NOD through BSNL by additional expense of Rs. 10 lacs. The complete amount will have to be paid to the BSNL by the university. This is how, as mentioned below, all 8 State Government universities will be paid Rs. 4,80,00,000/- (Rupees Four crore and eighty lacs only) amounting to Rs. 60,00,000/- (Rupees Sixty lacs) per university under IT Policy through Higher Education.

5. The expenses for the same must be debited under "Demand No. 9-2202- Samanya Shikshan-80-Samanya-800-Anya Kharch (22)-EDN-48 Mahiti and Pradyogik-Yantra Samgri and Sadhan Samgri (Planning) (117047) and be obtained from the provisions approved under the current year
6. This order has been issued and released under the administrative permission obtained to make expenditure for all provisions for the year 2009-10 through the note of the Chief Secretary (Expenses) Finance Department and Finance Advisor on 20-3-2009 and 07-08-2009 through the File No. IT-102009-2 Computer Cell.

Subject: Instructions regarding connectivity to the Government Institutions / Organisations under NKN on self-payment basis.

Ref:

- (1) NKN agreement between BSNL, NIC & NICSI dated 16.09.2010.
- (2) BSNL CO letter no. 5-149/2011/EB-I/Vol.II/121 dated. 03.12.2015
- (3) NKN notification of the tariff vide letter no. NKN/100069/GEN/ND-2 dt. 14.01.2021.
- (4) Letter No. CNNCO-12/13/3/2021-EB-I-Part (3) dated 19.04.2021.

(A) Brief of the case:

- (i) BSNL is providing telecom services to NKN in accordance to the tripartite agreement signed among BSNL, NIC & NICSI vide NKN Project Service Agreement dated 16.09.2010 under reference (1) (copy enclosed as Annexure-1).
- (ii) NIC & NICSI jointly known as Project Implementation Agency (PIA) of the NKN Project.
- (iii) The agreement was initially for 10 years w.e.f. 01.01.2010 to 31.12.2019 which was extended subsequently. Presently, NKN has informed extension of the project till 31.03.2022, which was already intimated to BSNL Circles vide letter dated 19.04.2021 under reference (4). Copy available on BSNL Intranet under NORTH (MNTC) unit on 20.04.2021.
- (iv) Links are broadly divided in two category viz. Core links (Bandwidth 10G & 2.5G) & Edge links (Bandwidth 10G, 1G & 100 Mbps). Edge links are also of two category viz. User links (connectivity to end user i.e. Institute / organisation) & District links (connectivity b/w NIC District HO).
- (v) Under the service agreement, there was centralized Work Order placing Authority & Paying Authority i.e. NICSI & 100 % bandwidth charges is being paid by NKN Delhi for the link hired centrally from BSNL Delhi.
- (vi) NKN project has unique payment terms. It was not implemented in CDR system. Manual entry is done in CDR System for each link for generation of bills from CDR each time. However, circuits are booked through CDR system.
- (vii) Tariff of Edge links was negotiated by NKN in 2015 with all service providers of NKN (BSNL, MTNL, RailTel & FGCIL). The tariff and payment terms accepted by BSNL CO and communicated vide letter

dated 03.12.2015 to EB NCR-I unit. Copy is enclosed as Annexure-2 (relevant 4 pages only). However, this tariff is not applicable as of now.

The tariff was further negotiated by NKN with service providers in the calendar year 2020.

- (viii) The notified tariff dated 14.01.2021 by NKN, applicable presently is enclosed as Annexure-3.
- (ix) Due to fund related issue, NKN had insisted for connectivity to the institute/ organisation on Self-fund basis i.e. 100% payment by the concerned institute / organisation on NKN tariff and payment terms and conditions as well as signing of a tripartite agreement with such institute / organisation though the same was not provisioned under NKN agreement. EB NCR-I unit had tried to get the simplified payment terms and condition and to not insist for tripartite agreement with each such institution. However, the same was not agreed by NKN.
- (x) Further, request from field units has also been received w.r.t. tariff for connectivity to such institute.

(B) Hence, in view of above, following instructions are being issued to BSNL Circles for connectivity under NKN to the Institutions / Organisations against Self-fund payment basis:

- (1) NKN connectivity on Self-fund basis to the Institutions/ Organisation can be provided only to those organisation, which have been granted approval in writing from competent authority of NKN i.e. from NKN Delhi & willing to take the link on nomination basis i.e. without floating any RFP/RFQ and Tender etc.
- (2) 100 % payment of bandwidth charge is required to be made by the concerned organisation in accordance to the terms and conditions of NKN.
- (3) Field units are requested to take duly filled CAF from the concerned institute / organisation and also a copy of approval letter from the competent authority i.e. NKN Delhi (on NKN letter head) which should have clear mention of the bandwidth to be provided to the concerned institute / organisation under NKN.
- (4) Connectivity to the institute / organisation will only be provided on the basis of self-fund basis by the field units.
- (5) Core link & District link (i.e. connectivity to the PoP of NIC / NKN) will be provided by EB NCR-I unit only.
- (6) It is important to mention that, the links on self-fund basis will be provided after issuance of this letter, hence, all links under self-fund basis will fall under the category of "New link" for which applicable tariff i.e. bandwidth charges are as below:

(7) Distance Slab is Chargeable Distance i.e. radial distance converted to Chargeable Distance by a multiplication factor 1.25

(8) The agreed tariff is on cost plus basis i.e. provision for the charges required against special construction towards OFC laying is not available.

Hence, the field units are free to decide on the feasibility of the link based upon business case. If the case is not a viable business case, field unit can refuse to provide the connectivity to the organisation. 

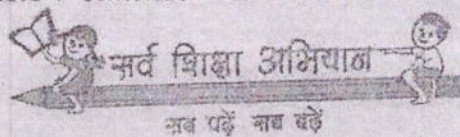
Kindly refer to my letter No. 16-3/2009-DL, dated 21st August, 2009 [copy enclosed] regarding Optical Fibre Cable (OFC) based 1 Gbps connectivity to National Knowledge Network (NKN) Point of Presence (PoP) to all the bonafide Universities in the country under the National Mission on Education through ICT (NME-ICT) on a 75 : 25 cost sharing basis between the Central Govt. and the Universities concerned, which includes university level institutions. You would be glad to know that BSNL – MTNL combine has started the work in this regard. This is in addition to the already ongoing work of progressively providing 10 Mbps Broadband over Virtual Private Network (BBoVPN) to all the bonafide Colleges of the country through upto 20 individual connections over copper wire with ADSL modems on 75 : 25 cost sharing basis between the Central Govt and the respective Colleges. You are also aware that 25 % contribution of the University and the College has to be paid by them to the BSNL directly. As indicated earlier, the approximate one time upfront payment for each University works out to Rs. 50 lac plus service tax for the connectivity for a 10 year period and Rs. 10 lac plus service tax for setting up a Local Area Network (LAN) of 400 nodes, if required by the University. In case of Colleges, approximate quarterly payment works out to Rs. 6500/- only. BSNL, on its part has agreed to provide 10% rebate on cost of connectivity.

2. As the connectivity is the key to delivery of e-contents and collaboration between institutions / academicians / experts / researchers, in order to fast track the roll out of connectivity to Universities and Colleges, I would request you kindly to expeditiously take the following steps:

(a) obtain required approvals for meeting the upfront payments to BSNL for the 1 Gbps link to NKN and for the LAN and to made adequate budget provision for the same,

(b) nominate a nodal officer whom BSNL / MTNL could contact for these works, and who, in turn, could co-ordinate these activities in the University on your behalf,

(c) identify a 10' x 10' room where the 1 Gbps connectivity could be provided and routers / switches for NKN connectivity and LAN could be placed,




(d) grant permission for laying of cables etc.,

(e) permit Principals of constituent and affiliated colleges of your University to avail of the BBoVPN connectivity at the costs indicated above, and also to consider providing space for erecting mobile tower of BSNL free of cost so as to get optical fibre in the college campus.

- (1) NKN agreement between BSNL, NIC & NICSI dated 16.09.2010.

- (3) NKN notification of the tariff vide letter no. NKN/100069/GEN/ND-2 dt. 14.01.2021.
- (4) Letter No. CNNCO-12/18/3/2021-EB-I-Part (3) dated 19.04.2021.

(A) Brief of the case:

- (i) BSNL is providing telecom services to NKN in accordance to the tripartite agreement signed among BSNL, NIC & NICSI vide NKN Project Service Agreement dated 16.09.2010 under reference (1) (copy enclosed as Annexure-1).
- (ii) NIC & NICSI jointly known as Project Implementation Agency (PIA) of the NKN Project.
- (iii) The agreement was initially for 10 years w.e.f. 01.01.2010 to 31.12.2019 which was extended subsequently. Presently, NKN has informed extension of the project till 31.03.2022, which was already intimated to BSNL Circles vide letter dated 19.04.2021 under reference (4). Copy available on BSNL Intranet under NORTH (MNTC) unit on 20.04.2021.
- (iv) Links are broadly divided in two category viz. Core links (Bandwidth 10G & 2.5G) & Edge links (Bandwidth 10G, 1G & 100 Mbps). Edge links are also of two category viz. User links (connectivity to end user i.e. institute / organisation) & District links (connectivity b/w NIC District HQ).
- (v) Under the service agreement, there was centralized Work Order placing Authority & Paying Authority i.e. NICSI & 100 % bandwidth charges is being paid by NKN Delhi for the link hired centrally from BSNL Delhi.
- (vi) NKN project has unique payment terms. It was not implemented in CDR system. Manual entry is done in CDR System for each link for generation of bills from CDR each time. However, circuits are booked through CDR system.
- (vii) Tariff of Edge links was negotiated by NKN in 2015 with all service providers of NKN (BSNL, MTNL, RailTel & PGCIL). The tariff and payment terms accepted by BSNL CO and communicated vide letter


